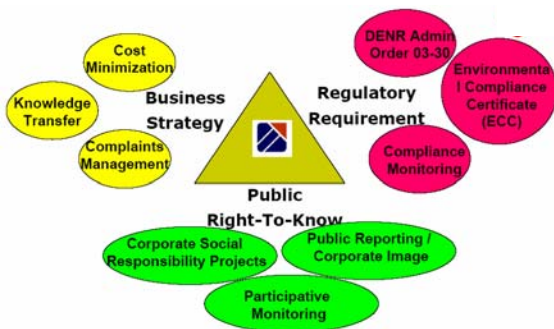




Multi-partite Monitoring Team

The PEZA-GTZ initiative for establishing a Management Approach to the Eco-Industrial Development of Philippine Economic Zones, referred to as the EID project, is working to promote and implement concepts of sustainable development, balancing economic development with environmental protection and social progress. This includes engaging partners to work for the overall improvement of environmental conditions within the industrial zone areas.

EID supports the use of combined strategies and synergies among concerned groups. The MMT is a systems-oriented and integrated approach in analyzing and finding solutions to environmental concerns. If successfully implemented, the mechanism facilitates the attainment and maintenance of the balance between socio-economic growth and environmental protection. The MMT supports the streamlining of environmental impact monitoring activities for projects located in a contiguous area, making it a practical and cost-effective option for industrial zones.

What is the MMT?

Multipartite Monitoring Team (MMT) is a mode of compliance monitoring for ECC conditionalities, particularly required for 'class A' projects. This is firmly institutionalized in the provisions of PD 1586 Implementing Rules and Regulations starting from DAO 1992 up to DAO 30 of 2003.

The purposes for organizing the MMT are to encourage public participation, greater stakeholders' vigilance and provide appropriate check and balance mechanisms in the monitoring of project implementation. The MMT also serves as the focal group to handle complaints from stakeholders at the local level.

Features of the MMT :

- Environmental Monitoring Work Plan is formulated annually by the MMT Techcom and approved by the MMT Execom.
- MMT Monitoring Report summarizes the compliance status of the Ecozone, with copies submitted to EMB.
- Shared ambient monitoring of the zone's environment.
- The MMT and EMB-7 compiles relevant records/data, compliance monitoring reports as well as environmental management best practices.
- Trainings will be provided to the MMT in the different aspects of monitoring, reporting and documentation to equip them with necessary technical understanding required of their tasks.
- Communities and other stakeholders will be made aware about the environmental programs of MEZ and its locators
- An Environmental Monitoring Fund (EMF) will be put up to cover the operational costs of the MMT
